TIPS TO REMEMBER ABOUT LAMBPLAN EBV'S:

1. For most commercial operations, BETTER GROWTH is vital. Rams must have + ve EBV's for weight.
2. The importance of Fat and Muscle EBV's depends on how the lambs will be sold and at what weight
 - for trade lambs sold in saleyards, Fat and Muscle not so important.
 - for heavier lambs sold via Value-based Marketing (contacts, grids etc), Fat and Muscle are very important.
3. Indexes are a guide – you must help the buyer or talk to your ram supplier to get the right EBV's
4. Every 1kg EBV for weight is worth 0.25-0.33kg extra carcass weight: \$125-\$150 extra over the life of a ram.
5. The 3 T's – Teeth, Testicles and Toes
Rams must have sound mouths, 2 functional, firm testicles and 4 clean, strong feet and toes



TRAITS THAT DEFINE THE VALUE OF TERMINAL SIRES

The skills in selecting terminal sires for lamb production is to identify those sires that have desirable genes that produce lambs with high growth rate, low fat (lean) and better carcass conformation. At present, we cannot directly measure the genes of an animal. LAMBPLAN can however provide an estimate of the value of a sire's genes by looking at his own performance for certain traits and that of his relatives. This estimate is called an Estimate Breeding Value (EBV). For terminal sires there are three main traits to concentrate on these being:

1. Post weaning weight (PWWT) – describe the animal's genetic merit growth rate. A positive EBV means the animal's progeny will be genetically faster growing. That is they reach market weight at an earlier age.
2. Post weaning fat (PFAT) – describe the value of each animal's genes for fat depth at constant weight – a negative EBV means that an animal's progeny will be genetically leaner animal.
3. Post weaning eye muscle depth (PEMD) – describe the value of each animal's genes for eye muscle depth at constant weight – a positive EBV means a genetically thicker-muscled animal, and one that will have slightly more of its lean tissue in higher-priced cuts.

HISTORY OF ALLENDALE POLL DORSET STUD

In October 1938 the late Mr Allen E. Day founded the Allendale Dorset Horn Stud. The Dorset Horn Stud had regular infusions of top sires mainly from the famous 'Newbold' and 'Balmoral' Studs.

In 1956 the extremely influential Valma Sire A11/54 was loaned by Mr L. A. Stuart Valmont' Whitemore, Tasmania, to commence the Allendale Poll Dorset flock. This great breeding ram was joined to 45 specially selected Allendale Dorset Horn ewes and this was the nucleus of the Poll Dorset Stud.

During the next three years all the Dorset Horn ewes were transferred to the Poll Dorset Stud. Six rams have been introduced from Valma, one from Kismet, one from Marylebone and three rams were loaned to the Stud by Marylebone for the 1972-73 mating.

Allendale has exhibited with great success at the Adelaide, Melbourne and Perth Shows and sales have been made to all states in Australia and New Zealand. A highlight of Allendale's show successes is that at the leading Poll Dorset Show in the Commonwealth (Melbourne

Royal) Allendale has exhibited the Champion Ram in 1970 and 1972 and the Champion Rams in 1968 and 1969 were by an Allendale sire. Quality Dorset Horn Ewes have been introduced from New Devon, Glen Devon, Balmoral, Deepfields, Lindsbury, Marylebone, Mandagery Park, Loddonlea and Kingswood Park Studs. In 1976 Valma W200/75 (twin) was purchased in partnership with Yaralla for \$3,400 and in 1978 Elouera Matchmaker was purchased for \$5,200.

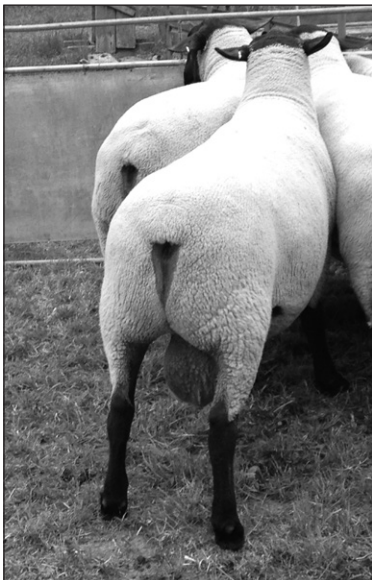
In 1986 Terringle 'Goliath' by Arnage Kiwi (imp. NZ) was purchased in partnership for \$11,500. His commercial qualities are valuable. In 1989 Ashban Quarter Master was purchased in partnership for \$21,000. Selected ewes are purchased from time to time and at the Malkay Dispersal in 1980 18 ewes were added to the flock.

The Stud's aim is to breed Poll Dorsets showing true 'Dorset' type and quality, firm fleshing, length, good hindquarter development and general soundness. As an additional selection and marketing tool Lambplan testing was commenced in 1989.

HISTORY OF ALLENDALE SUFFOLK STUD

The 'Allendale' Suffolk Stud was founded in 1931, when the late Mr Allen E. Day purchased top quality ewes at the dispersal of Mr H. C. Wright (Flock 35), Northfield S.A. and a further draft of ewes were secured from Buckland Park, Virginia S.A. These ewes were all rich in blood of the imported sires 'Brookhall Bismark' (imp.) and 'Risby Tory' (imp.).

The ram 'Liberty Hall Monarch' was purchased from the well known Liberty Hall Stud of the late Mr J. T. Murray, Woodside and it was this sire that revolutionised the modern Suffolk bred today at 'Allendale'. In 1937 the late Mr W. J. Dawkins selected 'Kirton New John' (imp.) and in 1952 Mr W. S. Martin selected 'Benacre Gomet' (imp.) for the Allendale Stud. Both rams have had great influence. In 1961 a ram and 20 ewes were selected from the 'Pembry' Stud and they have proved to be a valuable outcross.

In 1971 a Stonehaven ram was loaned to the Stud and in 1978 a Stonehaven ram was purchased. Further drafts of ewes were purchased from Stonehaven in 1985 and at the 'Dispersal' in 1991. In 1990 Pamellen 'Western' was purchased for \$5,000.

The 'Allendale' Stud has shown with outstanding success at the Adelaide, Melbourne, Sydney and Perth Royal Shows. 'Allendale' has exported Suffolk sheep to South Africa, India, South America, and great numbers to New Zealand. In addition a large clientele has been established in all states of the Commonwealth which proves the Allendale Suffolks are renowned for quality, carcase conformation and outstanding flesh qualities. As an additional selection and marketing tool we use Lambplan testing.
